(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100- - - - - DOLLARS (\$ 3000.00 ), with interest thereon from date at the rate of Six (6%) - - per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, situate on the southeast side of Sycamore Drive, being lot No. 154, on East Lynne Addition, recorded in Plat Book H at Page 220, and described as follows:

"BEGINNING at an iron pin on the Southeast side of Sycamore Drive, the joint front corner of lots 154 and 155, and running thence with the line of lot No. 155, S. 69-42 E. 110.1 feet to an iron pin; thence with the rear line of lot 187, N. 14-32 E. 50.25 feet to an iron pin; thence with the line of lot 153, N. 69-42 W. 105.1 feet to an iron pin on the Southeast side of Sycamore Drive; thence with the Southeast side of Sycamore Drive, S. 20-18 W. 50 feet to the beginning corner."
