porated herein by reference, in the principal sum of **Ninety-five Hundred Fifty and no/100**

Dollars (\$ 9550.00), with interest from date at the rate of

at the office of **four** per centum (**4** %) per annum until paid, said principal and interest being payable
in **Greenville, S. C.** **C. Douglas Wilson & Co.**, or at such other place as the holder of the note maydesignate in writing delivered or mailed to the Mortgagor, in monthly installments of **Fifty and 42/100**
Dollars (\$ 50.42), commencing on the first day of**November**, 1950, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of **October**, 1975.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of **Greenville**
State of South Carolina;

All that certain piece, parcel or lot of land, with the buildings and improvements
thereon, lying and being on the Southerly side of James Drive, near the City of Green-
ville, South Carolina, being shown as Lot No. 24 on the Plat of Orderest Park as
recorded in the RMC Office for Greenville County, S. C., in Plat Book "S", page 109,
said lot fronting 65 feet on the Southerly side of James Drive and having a depth of
160 feet on the Easterly side, a depth of 160 feet on the Westerly side and being
65 feet across the rear.

The mortgagor covenants that until the mortgage has been paid in full he will not
execute or file for record any instrument which imposes a restriction upon the sale
or the occupancy of the mortgaged property, on the basis of race, color or creed.
This covenant shall be binding upon the mortgagor and his assigns and upon the vio-
lation thereof, the mortgagee may, at its option, declare the unpaid balance of the

and are a portion of the security for the indebtedness herein mentioned;
