WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation
organized and existing under the laws of **South Carolina**, hereinafter

if not sooner paid, shall be due and payable on the first day of **October**, 19 **70**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of South Carolina:

All that piece, parcel or lot of land with the improvements thereon situate,
lying and being in Monaghan Mills Village, Greenville County, South Carolina, and
being more particularly described as Lot No. 56, Section 2, as shown on a plat
entitled "Addition to a Subdivision for Victor-Monaghan Mills, Greenville, S. C.",
made by Pickell & Pickell, Engineers, Greenville, S. C., on May 17, 1950, and re-

Street and fronts thereon 116 feet.
