GEORGE GERALD SMITH AND MARTHA W. SMITH of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

LIBERTY LIFE INSURANCE COMPANY, a corporation
organized and existing under the laws of South Carolina, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of Thirty-two Hundred Fifty - - - -
Dollars (\$ 3250.00), with interest from date at the rate of four and one-fourth per centum
(4 1/4 %) per annum until paid, said principal and interest being payable at the office of

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land, with the improvements thereon, situate,
lying and being in the Dunean Mills Village, Greenville County, South Carolina, and
being more particularly described as Lot No. 121, Section 4, as shown on a plat en-
titled "Subdivision for Dunean Mills, Greenville, S. C.", made by Pickell & Pickell,
Engineers, Greenville, S. C., on June 7, 1948, revised June 15, 1948, and August 7,
1948, and recorded in the R. M. C. Office for Greenville County in Plat Book S, at
pages 173-177, inclusive. According to said plat, the within described lot is also
known as No. 54 Smythe Avenue and fronts thereon 70 feet.

had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

assigns forever.
