(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lot No. 9 of Block O, on plat of Riverside, recorded in Plat Book A at Pages 322 and 323, and described as follows:

"BEGINNING at an iron pin on the Northeast corner of Palmetto Avenue and Pickens Street, and running thence with Palmetto Avenue, S. 79-45 E. 54 feet to a stake, joint rear corner of lots 9 and 10; thence with line of lot No. 10, N. 10-15 E. 125 feet to a stake on the South side of a 15 foot alley; thence with said alley, N. 79-45 W. 54 feet to a stake on the East side of Pickens Street; thence with Pickens Street, in a Southerly direction 125 feet to the beginning corner."
