"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of ... Greenville, Greenville. Township, School District 8-AB, about three miles North of the City of Greenville, being known and designated as Lot No. 207 of the property of Colonia Company, et al., as shown on a plat of the same prepared by Dalton and Neves, Engineers, September, 1925, recorded in the R. M. C. office for Greenville County in Plat Book G, page 112, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the North side of the Buncombe Road at the Western intersection of said road with Berkley avenue (which is shown on the above mentioned plat as an unnamed 35-foot street), and running thence along the West side of said Berkley avenue, N. 33-00 E. 200 feet to an iron pin at the intersection of said Berkley avenue with a 10-foot alley; thence along the South side of said 10-foot alley, N. 57-32 W. 65 feet to an iron pin at the joint rear corners of Lots Nos. 207 and 208; thence along the joint line of said lots, S. 33-00 W. 200 feet to an iron pin on the North side of the Buncombe road at the joint front corners of said Lots Nos. 207 and 208; thence with the North side of the Buncombe road, S. 57-32 E. 65 feet to an iron pin, the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by J. F. Welborn by his deed dated February 14, 1930, recorded in the R.M.C. office for Greenville County in Deed Vol. 152, page 154."
