"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, about two miles northeast from the City of Greer, lying on the East side of the Miller Road, bounded by lands of Henry Burnett's, Elzie Powell and Carrie Lou B. Collins, containing 1.34 acres, more or less, and having the following courses and distances: BEGINNING at a point or pin in the said Miller Road, corner with Henry Burnett, and runs thence N. 85.00 E. 375 feet to an iron pin on Elzie Powell's land; thence with his line S. 14.00 E. 150 feet to an iron pin on Elzie Powell's line; thence S. 84.45 W. 411 feet to an iron pin in the center of the Miller Road; thence with the center of said road S. 0.30 E. 150 feet to the beginning corner, being all of that property conveyed to me by Carrie Lou B.
