called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incor-
porated herein by reference, in the principal sum of Fifty Seven Hundred Fifty and no/100 - - -
----- Dollars (\$ 5750.00), with interest from date at the rate of
Four - - - - - per centum (4 %) per annum until paid, said principal and interest being payable
at the office of Canal Insurance Company
in Greenville, South Carolina, or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-four and
85/100 - - - - - Dollars (\$ 34.85), commencing on the first day of
December, 1950, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of November, 1970.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville
State of South Carolina;

All that lot of land on the Eastern side of Essex Court in the City of Green-
ville being shown as Lot 32 on a plat of Essex Court made by Dalton & Neves in May
1949, recorded in Plat Book W at page 31 and described as follows:

BEGINNING at a stake on the Eastern side of Essex 315 feet North from a county
road at corner of Lot 33 and running thence with the Eastern side Court N. 3-45 W.
60 feet to a stake at corner of Lot 31; thence with the line of said lot N. 86-
15 E. 123.5 feet to a stake; thence S. 5-52 E. 60.04 feet to a stake at corner
of Lot 33; thence with the line of said lot S. 86-15 W. 125.7 feet to the be-
ginning corner; and being the same property conveyed to the mortgagor by Central
