Carr under Trust Indenture dated 4/23/37, its successors and assigns,

Greenville Township, Greenville County, State of South Carolina, known and designated as Lot No. 14 of Circle Drive in a subdivision known as Sans Souci, according to a plat of property known as Franklin Heights made by Dalton & Neves, November 1940 and recorded in the RMC Office for Greenville County in Plat Book "L", at page 9 and having the following metes and bounds according to said plat:
