All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northeastern corner of Bennett Street and Boxwood Road near the City of Greenville, being shown as lot No. 15 on plat of Northwood made by Balton & Neves in June 1939, recorded in the R.M.C. Office for Greenville County in Plat Book "J" at Page 102, and described as follows:

**BEGINNING at a stake at the Northeastern corner of Bennett Street and Boxwood Road, and running thence with the Northern side of Boxwood Road, S. 71-32 E. 150 feet to a stake at corner of let No. 17; thence with the line of said lot, N. 19-30 E. 60.7 feet to a stake at corner of let No. 16; thence with the line of said lot, N. 150 feet to a stake on Bennett Street; thence with the Eastern side of Bennett Street, S. 19-30 W. 62 feet to the beginning corner.
