"BEGINNING at an iron pin on the southern edge of a five foot sidewalk running along Dukeland Drive at its intersection with the New Buncombe Road, and running thence with the right-of-way of the New Buncombe Road S. 39-10 E. 60 feet, more or less, to an iron pin, joint front corner of Lots Nos. 7 and 8; thence with the northern line of Lot No. 7, S. 50-50 W. 200 feet to an iron pin, joint rear corner of said Lots Nos. 7 and 8 thence N. 39-10 W. 78 feet to an iron pin on the southern edge of said sidewalk running along Dukeland Drive; thence along the southern edge of said sidewalk, N. 56-40 E. 200 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by Coke Smith and W. H. Hamby by deed of even date herewith, not yet recorded."
