

BEGINNING at an iron pin on the Northerly side of Pisgah Drive, joint front corner Lots #57 and #58, Block D, and running thence N. 17-13 E. 122.0 feet to an iron pin, joint rear corner Lots #57 and #58; thence S. 60-22 E. 150 feet to an iron pin on Pisgah Drive; thence S. 29-38 W. 40 feet to an iron pin on Pisgah Drive; thence around the curve of Pisgah Drive, the chord of which is S. 64-28 W. 78.7 feet to an iron pin also on Pisgah Drive; thence along the Northerly side of Pisgah Drive N. 71-0 W. 80 feet to an iron pin, the point of beginning.

BEGINNING at an iron pin on the Northerly side of Arlington Road, joint front corner Lots #21 and #22, Block E, and running thence N. 17-30 W. 100 feet to an iron pin, common corner of Lots #21, #22, and #50; thence N. 78-17 W. 111.3 feet to an iron pin on Pisgah Drive; thence along Pisgah Drive S. 5-10 E. 60 feet to a point on Pisgah Drive; thence continuing along Pisgah Drive S. 17-30 E. 71.1 feet to an iron pin on Pisgah Drive; thence around the curve of the Northeastern intersection of Pisgah Drive and Arlington Road, the chord of which is S. 62-30 E. 35.4 feet to an iron pin on Arlington Road; thence along the Northerly side of Arlington Road N. 72-30 E. 85 feet to an iron pin, the point of beginning.
