### To All Whom These Presents May Concern:

I, Bart Howard

SEND GREETING:

Whereas, I, the said Bart Howard  
 in and by my certain promissory note in writing, of even date with these  
 Presents, am well and truly indebted to Bank of Greer, Greer, S.C.  
 in the full and just sum of Thirty Seven Hundred Thirty Eight----41/100  
 , to be paid as therein stated

, with interest thereon from maturity  
 at the rate of 6 per centum per annum, to be computed and paid semi-annually  
 until paid in full: all interest not paid when due to bear  
 interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
 the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
 may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
 hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
 necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
 in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
 to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
 the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I, the said Bart Howard  
 , in consideration of the said debt and  
 sum of money aforesaid, and for the better securing the payment thereof to the said Bank of Greer,  
 Greer, S.C. or its Successors according to the terms of the said note, and also in  
 consideration of the further sum of Three Dollars, to me, the said Bart Howard  
 , in hand well and truly paid by the said Bank of Greer, Greer, S.C.  
 at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,  
 sold and released, and by these Presents do grant, bargain, sell and release unto the said  
 Bank of Greer, Greer, S.C.

All that piece parce, or lot of land in Highland Township, Greenville  
 County, State of South Carolina having the following description.:

BEGINNING on a stake in the old road and running thence with the  
 said road N. 48.00 E. 107 feet to the center of the surface-treated  
 road leading to Greer; thence with said surface-treated road S. 1.00  
 E. 157 feet to a pin in said road; thence N. 43.00 W. 119 feet to  
 the beginning corner. Containing fifteen one-hundreds (.15) of an acre  
 and lies on the west side of the road leading from Glassy Mt. to Greer  
 and this is a portion of the same land conveyed to J.A. Lindsey by  
 Green Lindsey, Exect. of R.L. Lindsey's estate, and is recorded in  
 the R.M.C. Office for Greenville County in Vol. 241, page 317. This is  
 the same property conveyed to me by J.A. Lindsey by deed dated August  
 25, 1950 and recorded in R.M.C. Office for Greenville County in Book  
 417 page 318.

BEGINNING on a stake in old road and running thence N. 79.30 E.  
 324 feet to a point in the center of the surface-treated road leading  
 to Greer; thence with said road N. 15.20 E. 95 feet to a point in said  
 road; thence N. 43.00 W. 119 feet to a stake in the old road; thence  
 with the old road S. 48.00 W. 353 feet to the beginning corner. (over)
