(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Four**

**Thousand Five Hundred**

DOLLARS (\$ **4,500.00** ), with interest thereon from date at the rate of **Six** per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal

Township, lying on the South side of the CCC Camp Road, about two miles Northeast from the City of Greer, being designated as a part of tract No. 3 on the Mrs. Eula A. Mayfield property, as shown by plat thereof made by H.S.G. Brockman, Surveyor, dated January 27, 1945, and being further shown as lots Nos. 2 and 3 on a plat of property made for B.W. Waters by H.S. Brockman, Surveyor, dated June 16, 1949, having the following courses and distances: Beginning on a stake on the South side of the C.C.C. Camp Road, joint corner of lots Nos. 1 and 2, and runs thence S. 13.30 E. 335 feet to a stake on line of lot No. 1; thence N. 76.30 E. 200 feet to a stake, corner of lot No. 6; thence N. 13.30 W. 377 feet to a stake on the South side of said road; thence with the South side of said road S. 67.44 W. 101.5 feet; thence continuing with the South side of said road S. 61.34 W. 103.2 feet to the beginning corner, being all of that property conveyed to me by B.W. Waters as shown by record of deed in the R.M.C. Office for Greenville County in Deed Book 420, at page 357. Also see record of the B.W. Waters plat in Plat Book U, at page 150.
