MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:  
Greenville Home Builders, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Citizens Lumber Company (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eighty-Five Hundred and No/100

DOLLARS (\$ 8500.00 ),

with interest thereon from date at the rate of Six. per centum per annum, said principal and interest to be repaid: \$85.00 on February 3, 1951, and a like payment of \$85.00 on the 3rd day of each month thereafter until paid in full, said payments to be applied first to interest and then to principal, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed semi-annually and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Frontus Street, in the City of Greenville, being shown as lot No. 47, on plat of Rockwood Park, recorded in Plat Book S at Pages 168 and 169, and described as follows:

"BEGINNING at a stake on the Eastern side of Frontus Street, 230 feet South from Sunset Drive at corner of lot 48 and running thence with the Eastern side of said street, S. 8-11 W. 87 feet to a stake at corner of lot 46; thence with the line of said lot, S. 81-49 E. 175 feet to a stake; thence N. 28-11 E. 46.5 feet to a stake at corner of lot 48; thence with line of said lot, N. 68-41 W. 179.4 feet to the beginning corner."
