TO ALL WHOM THESE PRESENTS MAY CONCERN: I, K.V. Sloan,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

FIVE HUNDRED DOLLARS (\$ 500.00), with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the East side of the Jordan Road, about one mile Southeast of the Jordan High School, bounded on all side by lands of T.S. Sloan, and having the following courses and distances: BEGINNING at a point in the center of the Jordan Road (stake on the northeast bank of the road), and being the southeast corner of the lot, and runs thence N. 49 E. 210 feet to a stake; thence S. 41 E. 210 feet to a stake; thence S. 49 W. 210 feet to a point in the center of the Jordan Road (stake on the northeast bank of the road); thence along the center of said road N. 41 W. 210 feet to the beginning corner, containing One (1) acres, more or less.
