GREENVILLE HOME BUILDERS, INC., (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Citizens Lumber Company, a Corporation

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Nine Thousand and No/100- - -

DOLLARS (\$ 9,000.00),

with interest thereon from date at the rate of six (6%) per centum per annum, said principal michanical to be repaid: \$90.00 on April 15, 1951, and a like payment of \$90.00 on the 15th day of each successive month thereafter; said payments to be applied first to interest and then to principal until paid in full, with interest thereon from date at the rate of 6%, per annum, to be computed semi-annually and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Rock-wood Drive, in the City of Greenville, being shown as Lot No. 80 on Plat of Rockwood Park, recorded in Plat Book S at Page 121, and having according to said Plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southern side of Rockwood Drive, at the joint front corner of Lots Nos. 79 and 80, and running thence with the line of Lot No. 79, S. 51-34 E. 230.3 feet to an iron pin; thence S. 42-07 W. 75.15 feet to an iron pin; thence N. 51-34 W. 225.2 feet to an iron pin on Rockwood Drive; thence with the Southern side of Rockwood Drive, N. 38-26 E. 75 feet to the point of beginning."
