### MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mary A. Crane, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Thousand and No/100- - - - - DOLLARS (\$ 4,000.00 ), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Augusta Road, known as Lot No. 13 of Block N of the O. P. Mills Property, according to Plat recorded in Plat Book C at Page 176, and is described as follows:

"BEGINNING at an iron pipe on the Western side of Augusta Road, 204 feet from the Southwestern corner of Augusta and Grove Roads; thence along line of Lot No. 12, S. 42-53 W. 179.85 feet to iron pipe on rear line; thence along rear line of Lots S. 47-52 E. 68 feet to an iron pipe, corner of Lot No. 14; thence along the line of Lot No. 14, N. 42-53 E. 179.9 feet to an iron pipe on the Western side of Augusta Road; thence along the Western side of Augusta Road, N. 47-57 W. 68 feet to the point of beginning."
