Four. Thousand, Fixe. Hundred. and. No./100. -.... (\$.4,500.00...) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of...... Forty-Four and No/100 - - - - - - - - - - - - (\$.44.00.....) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear. "All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of ... Greenville... and in Greenville. Township, School District 6-E, and being known and designated as Lot No. 58 of Map 1 of a subdivision known as Camilla Park, as shown on plat thereof recorded in the R.M.C. office for Greenville County in Plat Book G, at page 225, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the west side of Beatrice street at the corner of Lot No. 59, which point is 340 feet north of the northwest corner of the intersection of Beatrice street with Frances avenue, and running thence along the line of Lot No. 59, S. 67-58 W. 196.1 feet to an iron pin at the rear corner of said lot on a 20-foot alley; thence along the line of said alley, N. 18-32 W. 67.95 feet to an iron pin at the rear corner of Lot No. 57; thence along the line of that lot, N. 68-00 E. 197 feet to an iron pin at the corner of said lot on the west side of Beatrice Street; thence along the west side of said Beatrice Street, S. 17-50 E. 68 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
