TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, J. U. Gibbs and Irene C. Gibbs

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixty-Five Hundred and No/100- - - - - DOLLARS (\$ 6500.00), with interest thereon from date at the rate of Five (5) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northeast side of Sunset Drive, in the City of Greenville, known and Designated as lot No. 66 on Plat No. 2 of Sunset Hills, recorded in Plat Book P at Page 19, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northeastern side of Sunset Drive, at the joint front corner of lots Nos. 65 and 66, and running thence with the line of lot No. 65, N. 48-50 E. 175 feet to an iron pin on a 5 foot strip reserved for utilities; thence with said strip, S. 41-10 E. 75 feet to an iron pin at rear corner of lot No. 67; thence with the line of lot No. 67, S. 48-50 W. 175 feet to an iron pin on Sunset Drive; thence with the Northeastern side of Sunset Drive, N. 41-10 W. 75 feet to the point of beginning."

Being the same premises conveyed to the mortgagors by Paul H. Chapman by deed recorded in Book of Deeds 422 at Page 240.
