all that tract or lot of land in

Bates Township, Greenville County, State of South Carolina,  
in the Town of Travelers Rest on the Northwest side of McAlhany Road,  
being a part of Lot No. 1 on plat made by W. P. Morrow, Surveyor, March,  
1946 and according to said plat, in part, having the following metes and  
bounds, to wit:

BEGINNING at an iron pin on the Northwestern side of said McAlhany Road  
at corner of property conveyed to Hoyt L. Walters, and running thence  
North 48-00 West 312 feet along line of said Walters property to point;  
thence in a Southwesterly direction 200 feet, more or less, along line  
of Carl R. Vest to point at joint rear corner of Lots Nos. 15 and 16 on
