SEND GREETING:

Whereas, We, the said William E. Coker and Virgil M. Coker and  
Rossie McKinney  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to Farmers Bank of Simpsonville  
in the full and just sum of Thirty Five Hundred (\$3500.00)  
to be paid Thirty Dollars (\$ 30.00) each month for a period  
of one year with the remaining balance then to be paid.

with interest thereon from date  
at the rate of six per centum per annum, to be computed and paid monthly  
until paid in full: all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,  
sold and released, and by these Presents do grant, bargain, sell and release unto the said  
Farmers Bank of Simpsonville

All that piece, parcel and lot of land lying and being in the  
Town of Simpsonville, in the County and State aforesaid, at the north-  
west corner of Curtis Street and Academy Street and being the same prop-  
erty this day conveyed to William E. Coker and Virgil M. Coker by Rossie  
McKinney, R. B. McKinney, W. H. McKinney, Eloise M. Ellis, Ruth M. Smith,  
Edna May Giles and Virgil M. Coker by two deeds with the said Rossie  
McKinney reserving to herself a life estate in a one-third portion there-  
of; but with it distinctly understood and agreed that this obligation is  
to cover and include not only the interest which Mrs. Rossie McKinney  
conveyed to William E. Coker and Virgil M. Coker but the interest which
