on or before October 1, 1951,

until paid; interest to be computed and paid _____ and if unpaid when due to
bear interest at same rate as principal until paid, and have further promised and agreed to pay ten per
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceed-
ings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That _____, the said Greenville Airport Commission
in consideration of the said debt and sum of money
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in
consideration of the further sum of Three Dollars, to it in hand well and truly paid at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and
released, and by these presents do grant, bargain, sell and release unto the said R. F. Watson, his
heirs and assigns, forever;

All that tract of land in Greenville County, State of South Carolina,
on both sides of the road leading from State Highway No. 291 to the
Airport Control Tower and according to a survey made by J. C. Hill on
March 7, 1949, revised January 13, 1951, contains 24.46 acres, more or
less, and is described as follows:

BEGINNING at a point in the center of the road leading to the
Airport Control Tower, 869.6 feet Southeast from the right-of-way of
Highway No. 291, and running thence N. 55-45 E. 978 feet to a stake,
at corner of other property of the grantor; thence with the line of said
property, S. 36-10 E. 707 feet to a stake; thence continuing with the
line of said property, S. 33-30 W. 846 feet to a stake on the South side
of the said road leading to the Control Tower; thence with the South-
western side of said road, N. 44-50 W. 306 feet to a stake; thence leav-
ing said road, N. 87-20 W. 774 feet to a stake; thence N. 22-40 W. 50.2
feet to a stake; thence S. 71-45 W. 122 feet to a stake; thence N. 24-
45 W. 429 feet to a point in the forks of a branch; thence N. 82-50 E.
543 feet to the beginning corner.

and it is duly authorized by the Greenville Airport Commission.
