in the full and just sum of Nine Hundred & No/100 (\$900.00) - - - - - Dollars, in and by my certain promissory note in writing of even date herewith, due and payable

\$25.00 on April 1, 1951 and a like amount on the first day of each month thereafter for three years at which time the balance will be due and payable; payments to be applied first to interest, balance to principal with the privilege to anticipate payment of part or all after one year,

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. E. Robinson, as Trustee under the B. M. McGee Will, his successors and assigns, forever:

All those two certain pieces, parcels or lots of land in Paris Mountain Township, Greenville County, State of South Carolina, at the Southwest corner of the intersection of W. Decatur Street and Rodney Avenue and being known and designated as Lots Nos. 99 and 100 of the property of Margaret H. Beattie as shown on a plat thereof, as revised by Dalton & Neves, Engineers in April 1931, entitled Property of J. P. Rosamond recorded in the R. M. C. Office for Greenville County in Plat Book H, Page 186 and being described together, according to said plat, as follows:

BEGINNING at an iron pin on the Southwest corner of the intersection of W. Decatur Street and Rodney Avenue and running thence along Rodney Avenue, S. 64-45 E. 160 feet to an iron pin joint corner Lots Nos. 99 and 120; thence S. 22-30 W. 120.2 feet to an iron pin joint rear corner Lots Nos. 100 and 101; thence along the joint lines of Lots Nos. 100 and 101, N. 64-45 W. 165.8 feet to an iron pin on W. Decatur Street joint front corner Lots Nos. 100 and 101; thence along W. Decatur Street, N. 25-15 E. 120 feet to the beginning corner.
