"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, lying and being situate on the Northwest corner of the intersection of Pleasant Ridge Avenue and Prince Avenue, within the limits of the City of Greenville, being known and designated as lot No. 92, according to plat of Pleasant Valley, prepared by Dalton & Neves Eng. in April 1946, as revised through September 1950, recorded in the R.M.C. Office in plat Book P at Page 114, and described as follows:
