SEND GREETINGS:

Whereas, I the said Elizabeth B. Young in and by my certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina in the full and just sum of Twenty-Five Hundred and No/100 (\$ 2500.00 ) payable at the offices of said Association at Easley, South Carolina, with interest at the rate of Six per centum (6%) per annum, to be repaid in installments of Thirty-Seven and 50/100 (\$ 37.50 ) Dollars, due and payable upon the first day of each and every calendar month hereafter until the full principal sum with interest has been paid, said monthly installment to be applied first to the payment of interest, computed monthly on the unpaid balance, and then to principal; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, lying and situated in Grove Station School District, State and County aforesaid, and containing one-half of an acre more or less, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on banks of Moody Road, joint corner of Albert & Louree Turner; thence along Turner line, N. 20-30 W. 180 feet to iron pin, joint corner Turners and Mrs. E.A.
