in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said South Carolina National Bank, as trustee for Marie B. Marston, Account No. 2,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina on the south side of Ninth (9th) Street, in section No. 5 of Judson Mills Village, in the county of Greenville, being known and designated as lot No. 25 as shown on a plat of section No. 5 of Judson Mills Village made by Dalton and Leves, Engrs., in February, 1940, which plat is recorded in the R. M. C. Office for Greenville County in plat book "I", at pages 33 and 34 and having according to said plat, the following metes and bounds, to-wit:
