all that tract or lot of land in

Township, Greenville County, State of South Carolina. Greenville situate at the southeast intersection of West Coffee and North Academy Streets, and more particularly described as follows:

BEGINNING At the point of the Southeast intersection of said streets and running thence along the property line of Academy Street, S. 24-38 W. 100.60 feet, more or less, to a pin on 10-foot alley; thence along the North side of said alley approximately S. 63 E. 26.16 feet to line of lot No. 2; thence along the line of lot No. 2 ina straight line 100 feet to Coffee Street at a point 19.25 feet from the beginning corner; thence along said Coffee Street, N. 63 W. 19.25 feet to the beginning corner, together with the buildings thereon, and known as Lot No. 1 on a plat of the Estes property.
