in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms
of said note, and also in consideration of the further sum of Three Dollars tou.s, the said
W. H. Greene and Maggie M. Greene in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of ...Greenville, and in Chick Springs.

Township on the west side of Donnan Road (formerly Edwards Road), and being known and designated as Lot No. 48 of Plat No. 2 of a subdivision of the property of W. S.

Bradley, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book O, at page 169, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the West side of Donnan Road at the corner of Lot No. 47, and running thence along the line of said Lot No. 47, N. 88-10 W. 342 feet to an iron pin; thence S. 1-50 W. 100 feet to an iron pin at the rear corner of Lot No. 49; thence along the line of that lot, S. 88-10 E. 342 feet to an iron pin on the west side of Donnan Road; thence along the line of said Donnan Road, N. 1-50 E. 100 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to us by W. S. Bradley by deed dated October 1, 1946 and recorded in the R. M. C. office for Greenville County in Vol. 300, at page 21."
