TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, S. L. Robertson, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto H. C. Smith and C. S. Fox

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Hundred Ninety and No/100

DOLLARS (\$ 790.00),

with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid: On or before six months after date.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, and being known and designated as Lot No. 4 of a subdivision known as Vista Hills, recorded in Plat Book P at Page 149, and described as follows:

"BEGINNING at a point on the Southeastern side of Ridgecrest Drive at the joint front corner of Lots Nos. 3 and 4, said point being 155 feet Southwest of the Southwestern intersection of Ridgecrest Drive with Wellington Avenue, and running S. 41-24 E. 177 feet to a point on the Northwestern side of a County Road at the joint rear corner of Lots Nos. 3 and 4; thence with the Northwestern side of said County Road, N. 58-00 E. 70 feet to a point at the joint rear corner of Lots Nos. 4 and 5; thence N. 38-19 W. 197 feet to a point on the Southeastern side of Ridgecrest Drive at the joint front corner of Lots Nos. 4 and 5; thence with the Southeastern side of Ridgecrest Drive, S. 43-11 W. 80 feet to the point of beginning."

Said premises being the same conveyed to the mortgagor by Central Realty Corporation by deed to be recorded.
