WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Twenty-Five Hundred and No/100** -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as lot 3 on plat of the property of James M. Edwards made by Dalton & Neves in March 1949 and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southeastern side of Super Highway No. 29 at joint corner of lots 2 and 3 and running thence with the line of lot 2, S. 47-08 E. 325 feet to an iron pin in line of other property owned by James M. Edwards; thence with the line of said property, N. 42-52 E. 100 feet to iron pin at rear corner of lot 4; thence with line of lot 4, N. 47-08 W. 325 feet to iron pin on right-of-way of Super Highway No. 29; thence with the Southeastern side of right-of-way of Super Highway No. 29, S. 42-52 W. 100 feet to point of beginning.
