We, M. A. Creech, Jr. and Ruth G. Creech

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and No/100- - - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the East side of Broughton Drive, being known and designated as lot 50, Section H, as shown on a revised plat of Croftstone Acres, recorded in Plat Book T, at Page 311, and described as follows:

"BEGINNING at an iron pin on the East side of Broughton Drive, which pin is 330 feet North of U.S. Alternate Highway No. 29, and is the joint front corner of lots 50 and 51, and running thence with joint line of said lots, N. 87-54 W. 249.1 feet to an iron pin; thence N. 1-47 E. 80 feet to an iron pin, joint rear corner of lots 49 and 50; thence with joint line of said lots, S. 87-54 W. 249.8 feet to an iron pin in the East side of Broughton Drive; thence with said Drive, S. 2-06 E. 80 feet to the point of beginning."
