All that lot of land with the improvements thereon situate on the Southeast side of Crosby Circle, near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 87, on plat of Paramount Park, made by Piedmont Engineering Service, July 1949, recorded in the R. M. C. Office for Greenville County, S.C., in Plat Book "W", at page 57, said lot fronting 70 feet along the Southeast side of Crosby Circle, and running back to a depth of 196.4 feet on the Northeast side, to a depth of 177 feet on the Southwest side and being 72.8 feet across the rear.
