TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Samuel F. Ranspy

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seventeen Hundred and No/100- - - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, containing 2-1/10 acres, more or less, adjoining lands of Bill Bryson, Jim Lindley and Hattie Anders, and having the following courses and distances:

"BEGINNING at stake on Lindley line; thence with line of Hattie Anders N. 64 1/2 E. 7.10 to X in branch; thence down the said branch 6.43 to X, lands of Bill Bryson adjoining; thence S. 10-3/4 W. adjoining Lindley lands 7.49 to point of beginning."
