(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, near State Highway No. 14 and West thereof, about 1/2 mile North from Washington Baptist Church, and having the following courses and distances, to wit:

Beginning at an iron pin on the north bank of a county road leading from State Highway No. 14 to the Gap Creek Road, and running thence with said county road as follows, N. 55.44 W. 100 feet to iron pin in road ditch, N. 71.20 W. 100 feet to iron pin in said ditch, N. 65.35 W. 194.7 feet to iron pin in edge of road; thence S. 11.05 E. 179.8 feet to an iron pin on terrace bank; thence S. 67.58 E. 268.5 feet to iron pin in road; thence N. 33.11 E. 130.5 feet to the beginning corner, and containing 1.09 acres, more or less.
