All that certain lot of land in Paris Mountain Township, Greenville County, State of South Carolina, known as a part of the land conveyed to H. R. Scalf by deed from Margaret D. Morwood, and being the southwest portion of the 3.98 acre tract conveyed to James C. Denney and Dorothy Denney by Mrs. Birdie Scalf, said tract shown by plat made by Pickell & Pickell, Engineers, March 10th, 1950, and having the following metes and bounds according to said plat:

BEGINNING at the edge of a Country Road at the line of Clarence and Henry Laton Property, thence running S. 58 W. approximately 333 feet to an iron at a ditch, dividing line from Birdie Scalf land; thence with said ditch S. 44 W. 216.5 feet to a poplar on line of Truell property; thence with Truell line N. 2-21 E. approximately 223 feet to the edge of said Country Road; and thence along the edge of said Country road approximately 475 feet to the beginning corner.
