SEND GREETING:

Whereas, I, the said **J. T. Brashier**

C. and containing 1.60 acres according to a plat of property of W. W. Lindley place made by W. J. Riddle, Surveyor in October 1947, and having according to said plat the following metes and bounds:-

BEGINNING at an iron pin in the center of Neely-Ferry Road and running thence along the center of said road N. 22-55 East 200 Ft. to an iron stake; thence along the line of J. R.
