WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, known as Tract No. 6 on plat of property of Amanda Young, made by W. J. Riddle, Surveyor, September 1936, and recorded in the R.M.C. Office for Greenville County in Plat Book N at Page 107, and having the following courses and distances according to said plat:

"BEGINNING at a stone, corner of Tract No. 5, and running thence N. 88 W. 408 feet to iron pin; thence S. 88-50 W. 274 feet to stone; thence S. 2-30 W. 138 feet to stone, corner of lot No. 7; thence with line of said lot, S. 58-30 E. 537 feet to stone; thence with line of lots Nos. 2, 3 and 4, N. 37-01 E. 522 feet to the beginning, containing 4.37 acres.
