I, James O. Staton

(hereinafter referred to as Mortgagor) ·SEND(S)· GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Bank of Travelers Rest**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Three Hundred Fifty and No/100**

DOLLARS (\$350.00),

with interest thereon from date at the rate of **Six** per centum per annum, said principal and interest to be repaid: **\$25.00 on September 11, 1951, and a like payment of \$25.00 on the 11th day of each month thereafter until paid in full, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid annually in advance**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of **Three (\$3.00) Dollars** to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in **Bates Township, adjoining lands of S. A. Parker, H. D. Burns, Lumas and others and described as follows:**

"BEGINNING at an iron pin on Marietta-Pickens Road, thence running N. 27 W. 7.00 chs. to an iron pin; thence S. 74-15 W. 8.50 chs. to iron pin; thence N. 27 W. 7.00 chs. to iron pin; thence N. 74-15 E. 8.50 chs. to iron pin; thence S. 57 E. 12.00 chs. to iron pin on Pickens-Marietta Road; thence S. 11-30 E. 1.00 chs. to bend; thence S. 22 W. 3.00 chs. to bend in road; thence S. 58 W. 3.80 chs. to the beginning corner and containing 10 acres, more or less."
