TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, E. L. Darby and Wilda T. Darby

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Eighty-Five Hundred and No/100- - - - -** DOLLARS (\$ 8500.00), with interest thereon from date at the rate of **Five & One-Half** per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the **Southern side of E. Tallulah Drive, being a portion of lots 11 and 13 as shown on plat of property of D. T. Smith, recorded in Plat Book F at Page 108, and described as follows:**

"BEGINNING at a stake on the Southern side of E. Tallulah Drive, 66-2/3 Feet East from Smith Street, and running thence S. 25-40 E. 200 feet to a stake in line of lot 12; thence with the lines of lots 12 and 14, N. 64-20 E. 66-2/3 feet to stake; thence N. 25-40 W. 200 feet to a stake on E. Tallulah Drive; thence along the Southern side of E. Tallulah Drive, S. 64-20 W. 66-2/3 feet to the beginning corner."
