"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Eastern side of Keith Drive, containing 1.47 acres, more or less, and being more particularly described according to a survey by W.J. Riddle in March 1951, recorded in Plat Book Z at Page 179, as follows:
