NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, on the east side of the Rutherford Road, about three miles northwest from Greer, and being all of lots 11, 12, 16 and 17 on plat of the property of I. D. Bishop prepared by H. S. Brockman, Surveyor, July 20, 1948, and having the following courses and distances, to-wit:-BEGINNING on a stake on the East side of the old Rutherford Road at intersection with new Street, and runs thence along southern edge of said new Street, N 66-45 E three hundred eighty and five-tenths (380.5) feet to a stake at interesection of said Street and road; thence with the western edge of road, S 23-15 E one hundred (100) afeet to stake. joint corner of lots 17 and 18; thence with the common line of said lots 17 and 18 and also 10 and 11, 8 66-45 W three hundred eighty-two and three-tenths (382.3) feet to stake on the eastern edge of Rutherford Rpad; thence therewith, N 23-16 W-one hundred (100) feet to the beginning corner; and being the same conveyed to me by deed of W.
