To All Whom These Presents May Concern:

I, James C. Noe, of Greenville County, SEND GREETING:

WHEREAS, I the said James C. Noe

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, in the full and just sum of Nine Thousand, Five Hundred and No/100 - - - (\$9,500.00) Dollars, with interest at the rate of four (4%) per centum per annum, to be repaid in instalments of Fifty-Seven and 57/100 - - - - - (\$ 57.57) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I James C. Noe

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me,

the said James C. Noe in hand well and truly paid by the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and now within the corporate limits of the City of Greenville, being known and designated as Lot No. 77, Section A, of a subdivision known as Rockwood Park according to a plat thereof prepared by Pickell and Pickell, Engineers, August 24, 1948 and revised on October 5, 1948 and recorded in the R. M. C. office for Greenville County in Plat Book S, at pages 168 and 169, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the south side of Rockwood Drive, joint corner of Lots 76 and 77, and running thence with the line of Lot 76, S. 51-34 E. 245.9 feet to an iron pin; thence S. 44-17 W. 80.2 feet to an iron pin at the joint corner of Lots 77 and 78; thence with the line of Lot 78, N. 51-34 W. 240.5 feet to an iron pin on the south side of Rockwood Drive; thence with the south side of said Rockwood Drive, N. 38-26 E. 80 feet to an iron pin, the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by Hugh H. Byars by his deed dated December 5th, 1950 and recorded in the R. M. C. office for Greenville County in Vol. 424, at page 461."
