

BEGINNING at an iron pin on the North side of Cammer Avenue at joint front corner of Lots 24 and 25, said pin being 420 feet North-east of an iron pin located on the Northwest corner of the intersection of Cammer Avenue with Long Hill Street; thence N. 47-50 W. 166.05 feet to an iron pin at joint rear corner of Lots 24 and 25 on the South boundary of J. R. Jenkinson (or formerly) property; thence S. 42-07 W. 60 feet along the South boundary of J. R.
