TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, S. H. Forrester and Virginia Forrester

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100- - - - - DOLLARS (\$ 5000.00 ), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, on the East side of the C & W C Railroad, in the town of Mauldin, being more particularly described by a plat made by W. J. Middle, surveyor, dated in August 1951, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING in the center of an unnamed street, at front corner of said lot, and property owned by Sherman Fox, and running thence with line of Sherman Fox lot, N. 14-30 W. 200 feet to an iron pin; thence S. 75-40 W. 100 feet to iron pin; thence S. 14-30 E. 200 feet to center of unnamed street; thence with the center of unnamed street, N. 75-40 E. 100 feet to the beginning corner."

Being the same premises conveyed to the mortgagors by deed recorded in Volume 440 at Page 507.
