All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer and Chick Springs Township, lying on the South of Carey Avenue, being all of lot No. 17 on a Plat of the W. C. Smith Property made by H. S. Brockman, Surveyor, dated May 25th, 1936, and having the following courses and distances:-
