TO ALL WHOM THESE PRESENTS MAY CONCERN.

I, Fred J. Styles,

(hereinafter referred to as Mortgagor) SENDS GREETING

THE BRAS-AIR MORTGAGE WHICH AND TRULY INDULGED IN ALLEN L. EAGAN

HEREAFTER REFERRED TO AS MORTGAGEE IS EVIDENCED BY THE MORTGAGE, PURCHASED AND RECEIVED HEREBY, THE TERMS OF WHICH ARE HEREBY STATED FOLLOWS: IN THE SUM OF THIRTY-FIVE HUNDRED AND NO/100

DOLLARS (\$3500.00)

WITH INTEREST THEREON FROM DATE OF THE RATE OF SIX PER CENT PER ANNUM, AND PRINCIPAL AND INTEREST TO BE PAID ONE YEAR AFTER DATE WITH INTEREST THEREON FROM THAT DATE AT THE RATE OF SIX (6%) PER CENT, PER ANNUM, TO BE COMPUTED AND PAID SEMI-ANNUALLY.

I, FRED J. STYLES, DO KNOW ALL MEN BY THESE PRESENTS, THAT I, FRED J. STYLES, DO OWN THE ABOVE AND STATED LAND IN THE STATE OF SOUTH CAROLINA, AND IN ORDER TO SECURE THE PAYMENT THEREON, THE BETTER TITLE AND BETTER SECURITY WHICH THE MORTGAGEE MAY BE AWARE OF, I, THE MORTGAGOR, FOR A CONSIDERATION TO BE PAID ME BY THE MORTGAGEE, PAYMENT IN THE SUM OF THREE (\$3500) DOLLARS TO THE MORTGAGEE IN FULL WELL AND TRULY, PAID BY THE MORTGAGOR, AND BEING THE SAME, PAYING AND DELIVERING OF THESE PRESENTS, THAT I, FRED J. STYLES, DO HEREBY ACKNOWLEDGE, HAVE MORTGAGED, BOUND UP AND RELEASED, AND BY THESE PRESENTS DO, AGREE, BUT INDEED AND SOLELY OUT OF THE MORTGAGEE'S VOLUNTARY AGREEMENT, THE SUM OF THREE (\$3500) DOLLARS.

THE FOREGOING PLACE OF RECORD IS FIND, WITH ALL IMPROVEMENTS THEREON, AND OTHER UNDIVIDED DIMINISHING OWNERSHIP AND BEING IN THE STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE, IN BATES TOWNSHIP, AND DESCRIBED AS FOLLOWS:

"BEGINNING at an iron pin at the right-of-way of Hill Top Drive in the subdivision of Ray E. McAllister at Traveler's Rest and running from the joint corner of lot 34, along line of lot 34, N. 44-12 E. 200 feet to an iron pin at the rear line of lot 43; thence S. 45-45 E. 100 feet to an iron pin at the rear line of lot 43 and of the rear corner of lot 32; thence along line of said lot 32, S. 44-12 W. 200 feet to an iron pin at the right of way of said Hill Top Drive; thence N. 45-45 W. 100 feet along said Hill Top Drive to the beginning corner. THIS IS ACCURATE AS OF THE TIME OF PLAT MADE FOR RAY E. McALLISTER BY PICKETT & PICKETT, BIRMINGHAM, ALABAMA, ON SEPTEMBER 14, 1948. BEING THE SAME PREVIOUSLY CONVEYED TO THE MORTGAGOR BY ME AND RECORDED IN VOLUME 431 AS PAGE 130."
