TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, **Gerald K. Pressley**, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto LAURENS FEDERAL SAVINGS AND LOAN ASSOCIATION, LAURENS, S. C. (hereinafter referred to as Mortgagee), as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----Eighteen Hundred and no/100----- DOLLARS (\$ 1800.00), with interest thereon from date at the rate of -----six----(6 %) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Dunklin Township, containing 2 acres, estimated, more or less, and located on the southwest side of Highway U. S. 25, about 1 mile west of Princeton, fronting on and bounded on the Northeast by said U. S. Highway 25; on the southeast by lands of J. P. Davis; on the Northwest by lands now or formerly of W. V. Davenport and of Jos. T. Davenport; and on the northwest by a plot known as the Gaines burying-ground."

This being the identical lot conveyed to mortgagor by Berry Pressley by deed of even date and recorded simultaneously with this mortgage.
