TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Carl B. Holland

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

with interest thereon from date at the rate of Five per centam per annum, said principal and interest to be repaid: Six months after date, with interest thereon from date at the rate of Five (5%) per cent, per annum, to be computed and paid semi-annually

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lots 151 and 152, as shown on plat of Paramount Park, recorded in Plat Book W at Page 57, and described as follows:

"BEGINNING at an iron pin on the Southwest side of Crosby Circle, joint front corner of lots 152 and 153, which pin is 120 feet Southeast of the turnout point from Crosby Circle to Dorr Drive, and running thence with joint line of said lots, S. 40 W. 150 feet to an iron pin; thence S. 50-30 E. 140 feet to an iron pin, joint rear corner of lots 150 and 151; thence with joint line of said lots, N. 40 E. 150 feet to an iron pin in the Southwest side of Crosby Circle; thence with said Circle, N. 50-30 W. 140 feet to the beginning corner."
