MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Leland E. Burns and Constance T. Burns, of Greenville County SEND GREETING:

WHEREAS, we the said Leland E. Burns and Constance T. Burns

in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, in the

full and just sum of Two Thousand, Nine Hundred and No/100 - - - (\$ 2,900.00)

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of

Twenty-Nine and No/100 - - - - - (\$ 29.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That we, the said Leland E. Burns and Constance T. Burns

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, ac-

ording to the terms of said note, and also in consideration of the further sum of Three Dollars to us,

the said Leland E. Burns and Constance T. Burns

in hand well and truly paid by the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwestern side of Whitney Street in the Slater Manufacturing Company Village at Slater, and known and designated as Lot 1, Block F, as shown on a plat entitled "Plat Showing Revisions of Property of Slater Manufacturing Co., Slater, South Carolina," made by Pickell & Pickell, Engineers, Greenville, S. C., July 31, 1951, and recorded in the R. M. C. office for Greenville County in Plat Book AA, at page 115, and having, according to said plat, the following metes and bounds:

"BEGINNING at an iron pin at the intersection of Whitney Street and an unnamed street, and running thence along the Northwestern side of Whitney Street, S. 14-02 W. 52.8 feet to an iron pin; thence continuing with the Northwestern side of Whitney Street, S. 38-24 W. 62 feet to an iron pin; thence still with the Northwestern side of Whitney Street, S. 59-41 W. 90 feet to an iron pin at the intersection of Whitney Street with Circle Street; thence along the Northern side of Circle Street, N. 81-29 W. 33.3 feet to an iron pin at the joint front corner of Lots 1 and 2, Block F; thence along the common line of said two lots, N. 7-11 E. 131 feet to an iron pin on the Southern side of an unnamed street; thence along the Southern side of said unnamed street, S. 74-00 E. 22.5 feet to an iron pin; thence continuing along the Southern side of said unnamed street, S. 87-55 E. 54 feet to an iron pin; thence still with the Southern side of said unnamed street, N. 74-54 E. 72 feet to an iron pin, the point of beginning, includ-
